1. The said acceptance to establish new school in Zone No.13 of Dist: North West B shall be limited only for a period of 05 (five) years w.e.f. 8/3/2013 to 8/3/2018.
2. The acceptance to establish new school will automatically lapse, if the Society/Trust fails to obtain recognition as laid down in Rule 50 and 51 of D.S.E.A & Rules, 1973 within a period of five years.
3. Standard preliminary norms for recognition of the school are enclosed for favour of your appraisal and guidance.
4. This is issued subject to the condition that the school will follow the directions of the department issued from time to time.
5. That no request for sponsorship of land at any stage will be considered.
6. This essentiality certificate is subject to the outcome of notification to be issued by the Ministry of Urban Development, Govt. of India, with regard to non confirming areas.
